Speakers' biographies



Jacek KRAWCZYK is the President of the Employers Group at the European Economic and Social Committee (EESC). He was the Vice-president of the EESC between 2010 and 2013 with responsibility for the budget. He is a member of the European Economic and Social Committee since 2004. He is the Vice-president of Polish Confederation *Lewiatan*, the largest confederation of private employers in Poland. He is an entrepreneur with many years of experience and he was a former board member of several banks and companies from various branches of the economy: IT, transport, insurance and aviation.



Eberhard BÖMCKE is Senior Advisor and Deputy Head of the Operations and Mandate Management Division in the European Investment Bank. He was recruited at the European Investment Bank in 1994 to build up a brand new Credit Department. Once it was up and running, he returned to the EIB operations dealing with projects in Belgium, the Netherlands and Luxembourg. Before this, he held various functions in the commercial banking sector, ranging from Corporate Banking, Forex, Workouts and Credit Control ending up in the Management of one of the German's Bank Credit Department in Brussels.



Stratos PARADIAS is the President of the International Union of Property Owners (UIPI) since 2005. Before that, he was UIPI Secretary General for many years. He is a Supreme Court Lawyer in Athens, specialised in Property Law. In 1983, he founded the Hellenic Property Federation (POMIDA), based in Athens, and he is its President since 1996. He was a member of the Greek State Committee for Legislation (1984-1991) as well as a member of the State Committee for the Taxation of Real Estate Property (1997) and the National Council against Tax Evasion (2008). He was also a member of the City of Athens Buildings Renovation Committee for the Athens Olympic Games (2002-2004).



Patrick LIÉBUS is the President of the European Builders Confederation (EBC), the organisation representing construction SMEs in Europe, since 2015. He is also a member of the Employers Group of the European Economic and Social Committee (EESC) in Brussels. In France, he is the President of the Confederation of the micro and small construction businesses (CAPEB), and the Vice-President of the Professional Union of micro-enterprises (UPA) since 2010. He is a roofer and a slater, with also training in the field of carpentry. He holds the title of *Master Roofer*.



Vincent PIBOULEU is the Director of the Public Service for Energy Efficiency of the Picardie Region (France) since 2014, where he manages the public office and establishes the strategic orientations. Before this, he worked for the French National Agency for Environment and Energy Management (ADEME), first in charge of energy and industrial policies, and then responsible for climate and energy planning policies. In this context, he worked on the regional scheme for climate, air and energy in Picardie, within which the setting up of the Public Service for Energy Efficiency was a very important deliverable.



Maria SPYRAKI is a Greek Member of the European Parliament for the European People's Party Group since 2014. She is a member of the Committee on Regional Development and substitute member in the Committee on Industry, Research and Energy. She has worked for more than 22 years as a journalist in both the print press as well as in major television networks like SKAI, STAR, ALTER and MEGA. Maria Spyraki worked in the European Parliament between 2003 and 2004 at the Press Office and was the Head of Communications at the office of Commissioner Stavros Dimas during the 2004-2009 term.



France BAUVIN is a Board member and European Delegate of the French Association of Property Owners UNPI. She is also one of the Administrator of the UNPI in Department 44, Loire-Atlantique in the Prefecture of Nantes, Pays de la Loire. She was elected Secretary General of the International Union of Property Owners UIPI in September 2014. Before that, she was one of the Vice-Presidents of UIPI. In her professional career, France Bauvin has held high financial and management responsibilities in several companies and worked for around thirty years in a global industrial group.



Luca BERTALOT is the Secretary General of the European Mortgage Federation - European Covered Bond Council (EMF-ECBC), representing the interests of EU mortgage lenders and the covered bond community. He joined the EMF-ECBC in 2006, becoming Head of the ECBC in 2007 and being appointed Secretary General in June 2014. Prior to this, he worked as a financial analyst in Italy and Australia.
